Dear Secretary Chiavetta:

On April 30, 2010, PPL Electric Utilities Corporation ("PPL Electric") filed the above-referenced Petition to amend its Supply Master Agreement for allocation of Auction Revenue Rights ("ARRs") under its Pennsylvania Public Utility Commission ("Commission") approved Default Service Procurement Plan. On May 20, 2010, the Office of Consumer Advocate ("OCA") filed an Answer to the Petition, raising certain concerns. OCA is the only party that filed an Answer to the Petition.

PPL Electric and OCA have held discussions regarding OCA's concerns. As a result of these discussions, PPL Electric has agreed that, as part of its next default service procurement plan filing, for the period beginning June 1, 2013, PPL Electric will submit a study, based upon available information, comparing bid prices received for contracts in which ARRs are assigned to bidders with bid prices received for contracts in which ARRs are retained by the default service provider. The purpose of this study is to provide information that may be used to guide the allocation of ARRs in the future.

PPL Electric has been advised by OCA that, with this commitment, OCA agrees to withdraw any objection to PPL Electric's Petition. Therefore, PPL Electric respectfully requests that the Commission schedule PPL Electric's Petition for the next available Public Meeting and act to approve PPL Electric's Petition.
