

PLAINTIFF’S MOTION FOR CONTINUANCE OF HEARING

AND NOW COMES, Plaintiff, by and through counsel, Nestico, Druby & Hildabrand, PC, moves this Honorable Court for a continuance of the scheduled Hearing and sets forth the following in support thereof:

1. Plaintiff, the Estate of Margaret R. Harris, filed a Formal Complaint against Philadelphia Gas Works (“PGW”) with the PUC on February 16, 2010.
2. On February 26, 2010, Laureto Farinas, Esquire was served with notice of the complaint against PGW, which gave PGW twenty (20) days to respond to Plaintiff’s Complaint.
3. On March 18, 2010, Laureto Farinas, Esquire served a copy of Defendant’s Answer on Plaintiff’s counsel.
4. Plaintiff disagreed with the response and requested that a hearing be scheduled.
5. On June 1, 2010, the Honorable Cynthia Williams Fordham was assigned to this matter, and she issued a Prehearing Order that, among other things, scheduling a hearing for July 7, 2010, at 10:00 a.m.
6. Plaintiff is requesting a continuance of this hearing.

7. Plaintiff's counsel is requesting additional time within which conduct discovery to determine possible witnesses with personal knowledge of the meter readings at issue in this matter.

8. Further, Plaintiff's counsel intends to conduct discovery to determine possible witnesses with personal knowledge of the August 14, 2003 PGW bill for \$3,013.28, which is at issue in this matter.


9. Additionally, Plaintiff's counsel has two (2) other court obligations on July 7, 2010, the original date of the scheduled hearing.

10. On June 24, 2010, Plaintiff's counsel attempted to consult with opposing counsel with respect to his position on this request for a continuance. As of the filing of this Motion, Plaintiff's counsel has not received a response from opposing counsel.


