Petition for Issuance of Subpoena

To Administrative Law Judge Ky Van Nguyen:

PECO Energy Company, by its attorney, Tishekia Williams, Assistant General Counsel, petitions for issuance of SUBPOENA and in support thereof represents as follows: The name and address of respondent is PECO Energy Company, 2301 Market Street, Philadelphia, PA 19101-8699. The name and address for the attorney of the respondent is Tishekia Williams, 2301 Market Street, S23-1, P.O. Box 8699, Philadelphia, PA 19101-8699.

1. By Pre-hearing Order dated April 15, 2010, PECO received notice that a hearing is scheduled in this matter for May 24, 2010 at 1:00 P.M. The purpose of the hearing is to afford all parties of record the opportunity to submit testimony in the above-captioned proceeding.

2. The hearing scheduled for May 24, 2010 was continued at Complainant's request. By hearing notice dated June 1, 2010, a hearing was scheduled for July 14, 2010 at 10:00 AM.

3. On July 12, 2010, the undersigned was notified that Counsel for Complainant requested a continuance of the hearing scheduled for July 14, 2010. As a professional courtesy, Respondent did not object. By hearing notice dated July 12, 2010, the hearing scheduled for July 14, 2010 was cancelled.

4. Complainant alleges in his formal complaint that he has never resided or requested service at 404 Chestnut St., Upper Darby, PA and that any charges billed to him at that

address are a result of identity theft. Service at that address was in Complainant's name from August 1, 2005 until September 16, 2008.

5. While the service was in Complainant's name at 404 Chestnut Street., Upper Darby, LIHEAP issued a grant to Complainant at that address. To receive a LIHEAP grant, a customer must submit an application and proof of identification.


6. The Pennsylvania Department of Public Welfare ("DPW") confirmed that they have an application that includes a "PECO bill, pay stubs and identification for several household members," but will not release any information to PECO regarding the LIHEAP application without an order from the Commission.

7. The LIHEAP application contains documents indicating the identity and residence of the applicant, and will help determine if service was in Complainant's name as a result of identity theft. These issues are critical to the disposition of the case.

8. WHEREFORE, PECO Energy Company requests your honorable Administrative Law Judge to grant its PETITION FOR ISSUANCE OF SUBPOENA, directing the Pennsylvania Department of Public Welfare to release the 2007-2008 LIHEAP application and accompanying documentation that resulted in the grant issued to Rohan Green at 404 Chestnut Street., Upper Darby, PA.


