Dear Secretary Chiavetta:

On July 12, 2010, PPL Electric Utilities Corporation ("PPL Electric") was served with the above-docketed Petition of Eric J. Epstein. In the Petition, Mr. Epstein seeks to intervene in PPL Electric's Universal Service and Energy Conservation Plan filing ("USECP Filing") at Docket No. M-2010-2179796. That filing was made on June 1, 2010. Mr. Epstein further seeks to enforce a prior Pennsylvania Public Utility Commission ("Commission") Order that directed PPL Electric to serve a copy of the USECP Filing upon Mr. Epstein and the Sustainable Energy Fund ("SEF").

This letter is to advise the Commission that, due to an administrative oversight, the USECP filing was not previously served upon Mr. Epstein and SEF, but that upon receipt of the aforementioned Petition, a copy of the USECP Filing was e-mailed to both Mr. Epstein and SEF. PPL Electric regrets the oversight.


PPL Electric notes that no administrative action has been undertaken with respect to its USECP Filing, and thus neither Mr. Epstein nor SEF have been deprived of any due process rights or have otherwise been prejudiced as a result of PPL Electric's oversight. PPL Electric does not object to Mr. Epstein's intervention in the USECP Filing. PPL Electric further notes that issues related to PPL Electric's Universal Service programs have been raised in PPL Electric's pending base rate proceeding at Docket No. R-2010-2161694. Both Mr. Epstein and SEF are parties to that proceeding.
