


**PETITION TO INTERVENE OF PHILADELPHIA HOUSING AUTHORITY**

Pursuant to 52 Pa. Code §§ 5.71, *et seq.*, the Philadelphia Housing Authority ("PHA") hereby petitions to intervene in the above-captioned proceeding. In support of this Petition, PHA states as follows:

- 1). PHA is a customer of PECO Energy Company ("PECO") and owns and operates more than 14,000 housing units in the City of Philadelphia serving more than 80,000 residents.
- 2). Pursuant to 52 Pa. Code § 1.54(b)(3), the undersigned counsel should be served and consents to the electronic service of all documents at the e-mail address shown above.
- 3). On March 31, 2010, PECO filed a request for a base rate increase for electric.
- 4). PHA anticipates numerous issues being raised in this proceeding that will or may affect its interests as a customer of PECO. In addition, issues may be raised by various parties concerning the safety or reliability of PECO's service.
- 5). No other party to this proceeding represents the interests of PHA.



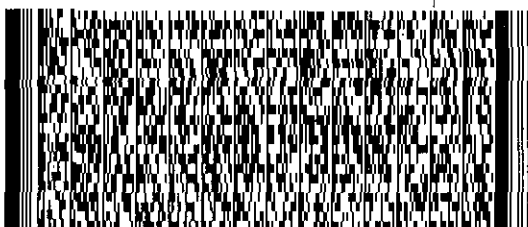

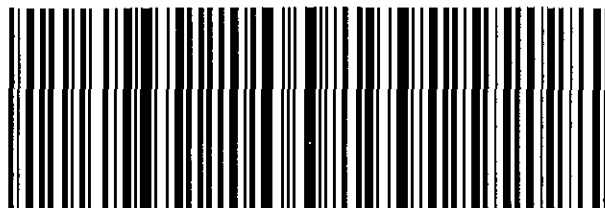
