SETTLEMENT AGREEMENT

Pat McArdle v. Duquesne Light Company

On June 25, 2010, Marie Tamilia of Duquesne Light Company contacted Pat McArdle and discussed settlement of his Formal Complaint.

A settlement agreement was reached between Ms. Tamilia, representing Duquesne Light Company and Mr. McArdle. We agreed to the following:

- *Duquesne Light Company reduced the security deposit requirement for Mr. McArdle from \$98 to \$38. Once the \$38 security deposit is paid, electric service will be established in the name of Pat McArdle at 407 S. Evaline Street, Apt. 8, Pittsburgh, PA 15224.
