PUBLIC STATEMENT OF THE
OFFICE OF CONSUMER ADVOCATE
PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. Section 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (PUC or Commission). In accordance with Act 161, and for the following reasons, the Consumer Advocate determined to file a Notice of Intervention and participate in proceedings before the Commission involving the Formal Complaint filed by the Retail Energy Supply Association.

On May 21, 2010, the Retail Energy Supply Association (RESA) filed a Formal Complaint to the revised Electric Generation Supplier Coordination Tariffs that were filed by Metropolitan Edison Company (Met-Ed) and Pennsylvania Electric Company (Penelec) on March 31, 2010. The Formal Complaint involves issues related to the 2009 Settlement of the Met-Ed and Penelec's 2011-2013 Default Service Plan. The OCA was a party to that Settlement. The Consumer Advocate determined to intervene in this proceeding to protect the interests of the Companies' residential customers and to ensure that the protections contained in the Met-Ed and Penelec 2009 Default Service proceeding are properly maintained.
