Dear Madam,

In my earlier letter I communicated you about my absence from USA till around August 5, 2010. Please note that I have returned to USA and am ready to conduct any activity [either in writing or through personal presence] related to the above case. I am ready to attend any hearing personally if it is scheduled excluding September 26 and 27, 2010. Since this is a long pending case and a quick resolution is to the best interest of fair justice [*Justice Delayed is Justice Denied*]. I ask your favor to take all necessary steps so that a fair resolution can ensue at the earliest.

In my earlier letter I mentioned that availability of a few documents is essential for me to represent my case effectively. I also mentioned that if the concerned party who is in possession of respective documents should feel that they are not obligated to provide me those, they should at least let me know so. For your quick reference I am noting the documentation that I feel necessary to represent myself effectively during the next hearing: (a) entire transcript of the initial hearing of the Administrative Judge. (b) the information whether or not I will have the opportunity to cross examine the person/s directly involved in affixing the various notices in my home. Additionally, as requested earlier I would appreciate your informing me the details of the authority where I can apply to get redress of my perception that PUC did not do what an average constituent can expect them to do to protect the constituent's legitimate interest.

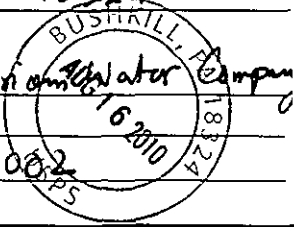

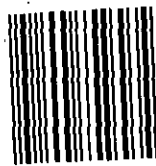
