


PROTEST

1. The service facilities of the Protestant and other authorized carriers are ample to meet all the requirements of the traveling public in the territory involved in this Application.
2. The approval of the Application would be prejudicial to your Protestant and other authorized carriers in this territory in that it will authorize additional competition with the potential resulting loss in revenue and less satisfactory service of the public.
3. Approval of the Application would be contrary to the public interest.
4. Your Protestant holds operating authority docketed to A-00107294. A copy of said authority is attached hereto as Exhibit "A" and made a part hereof.
5. Protestant is not aware of any amendment which would satisfy its interest, but is willing to discuss the same with Applicant or Applicant's counsel.
6. Pursuant to Section 333(c) of the Public Utility Law, Protestant request Applicant or its attorney to furnish the undersigned with a list of the names and addresses of all witnesses whom it intends to call, and the names and addresses of the supporting organizations they will represent, at least ten (10) days prior to the commencement of evidentiary hearing in this case.

WHEREFORE, Bucks County Transport, Inc. respectfully prays that the above Application be dismissed.

SCOPE OF OPERATING AUTHORITY

A-00107294, Folder 2, Am-C

To transport, as a common carrier, persons, in paratransit service, between points in the County of Bucks, and from points in said county, to points in the counties of Northampton, Lehigh, Montgomery and Philadelphia, and vice versa;

subject to the following condition:

- (1) That any service provided under the authority granted herein shall be provided in vehicles having a seating capacity of twenty-eight (28) passengers or less, excluding the driver.
- (2) That no right, power of privilege is granted to originate service from points in the county of Montgomery.


