Dear Secretary Chiavetta:

Pursuant to the March 5, 2010 Order Granting Motion for Stay entered by Presiding Administrative Law Judge Kandace F. Melillo, the above-captioned proceeding was stayed. At that time, the parties were awaiting a decision from the Commission regarding material questions then pending in a similar proceeding which the parties agreed would have a direct impact on this proceeding. *See Core Communications, Inc. v. AT&T Communications of PA, LLC and TCG Pittsburgh, Inc.*, Docket Nos. C-2009-2108186 and C-2009-2108239 (the "AT&T Proceeding"). Consequently, the Initial Prehearing Conference scheduled in this case was cancelled pending further order.

On May 21, 2010 the parties filed a Joint Status Report requesting that this proceeding continue to remain stayed as the Commission had not yet addressed the pending material questions in the AT&T Proceeding.

The purpose of this letter is to inform you that the Commission recently issued a decision in the AT&T proceeding. By order entered September 8, 2010, the Commission determined that it has subject matter jurisdiction to address Core's complaint and returned the AT&T Proceeding to the Office of Administrative Law Judge for further proceedings.

As a result of the Commission's recent action, Core respectfully requests that the stay in this proceeding be lifted and that an Initial Prehearing Conference be scheduled. The parties are in the process of resuming discovery and addressing other procedural matters.



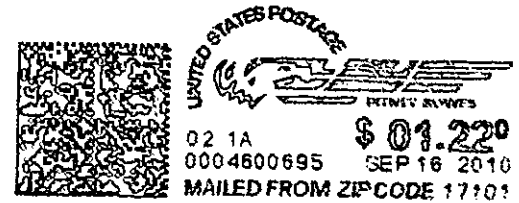
