

PPL hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission, have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL:

(a) Complainant was re-billed the amount of \$955.62 relevant to an stopped electric meter;

(b) PPL agrees to discount the re-billed about by 20%;

(c) Complainant agrees to pay the remainder of the re-billed amount, \$764.50, in equal monthly installments of \$31.85 over a period 24 months beginning with his October, 2010, electric bill; and


(b) Complainant agrees to withdraw its Complaint with prejudice.

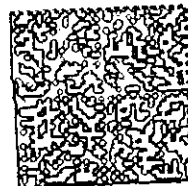

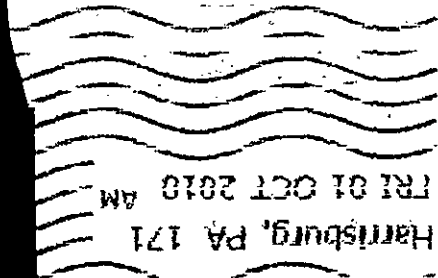
