This is in follow up the Pennsylvania Public Utility Commission's (the "Commission") order (the "Order") entered on March 29, 2010 regarding McLeodUSA Telecommunications Services, L.L.C.'s ("McLeodUSA") and US LEC of Pennsylvania L.L.C.'s ("US LEC") (together, the "Parties") joint application (the "Application") for *pro forma* intracorporate reorganization and for McLeodUSA's name change. As discussed in the Parties' Application, the Parties undertook a *pro forma* corporate reorganization which did not change the ultimate ownership or control of the Parties' operations or their corporate directors, officers, or managers, or their service offerings and pricing other than those done in the normal course of business operations. Further, McLeodUSA was an incorporated company operating under the name McLeodUSA Telecommunications Services, Inc., has since changed its corporate form by converting to a limited liability company, and now operates under the name McLeodUSA Telecommunications Services, L.L.C.



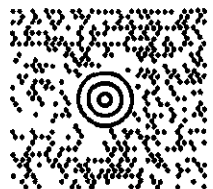

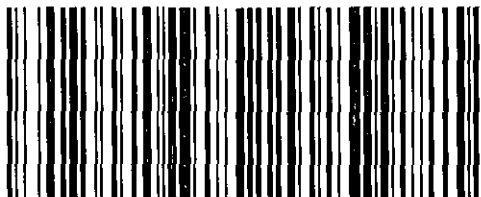
