IN ORDER TO END THIS LEGAL MATTER..I HAVE ASKED PPL TO STATE EXACTLY WHAT THEIR CCR DID..WHERE THEY WENT...WHAT THEY SAW TO DETERMINE THIS FOREIGN WIRING. THEY HAVE NEVER ANSWERED THIS QUESTION.

I HAVE NEVER MADE ANY CHANGES TO MY HOME SINCE I BOUGHT IT IN 1987. IT HAS 1/2 BATHS AND ONE KITCHEN. THIS COULD EASILY BE ACCOMPLISHED TO HAVE SOMEONE COME TO MY HOME. OR TO LOOK IT UP ON THE RECORDS OF MONROE COUNTY.

IN ADDITION, PPL STATES THEY DO NOT HAVE TO ANSWER QUESTIONS I SUBMITTED. I REQUEST INFO AS TO WHERE IT STATES THEY ARE ALLOWED TO DISMISS MY QUESTIONS AS THEY SAY IN THEIR PAPERS.

DOCUMENTATION WAS TO BE FORTHCOMING..NEVER RECEIVED ANY DOCUMENTATION. ALLEGATIONS OF MY HAVING OTHER UNLAWFUL THINGS. THIS THEY QUOTED IN THEIR PAPERS TO ME. I AM REQUESTING DOCUMENTATION OF THESE ADDITIONAL ALLEGATIONS.

I AM 66 YEARS OLD, LIVING ON SOCIAL SECURITY, ONLY..1000. MY BROTHER AND SON HELP ME FROM TIME TO TIME. I DO NOT FEEL THIS IS FAIR FOR ME TO UNDERTAKE THIS LARGE AMOUNT OF PPL MONIES, SINCE PPL TOOK IT UPON THEMSELVES TO CHANGE THE BILLING, AND MADE IT ALL RIGHT FOR MS. I AM SENDING YOU THIS LETTER , AND BELIEVE THIS WILL BE FORWARDED TO THE LAW OFFICE REPRESENTING PPL. I AM ALSO REQUESTING A FAIR BUDGET PLAN AND A FAIR DECISION REGARDING WHAT IS CLEARLY A MISTAKE ON THE CSR...LISTENING TO MS. LICITRA.

THANK YOU FOR YOUR IMMEDIATE ATTENTION AND HOPEFULLY I WILL NOT GET FURTHER CITATIONS FROM THE LAW FIRM COMING UP WITH MORE TEDIOUS WORK ON MY PART.

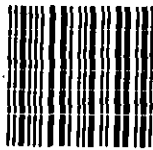

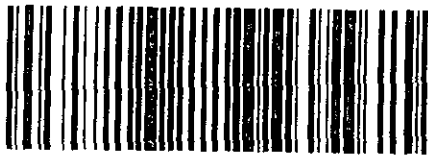
