**PETITION TO WITHDRAW OF THE PENNSYLVANIA
ASSOCIATION OF COMMUNITY ORGANIZATIONS
FOR CHANGE NOW (“ACORN”)**


TO THE HONORABLE PENNSYLVANIA PUBLIC UTILITY COMMISSION:

1. The Pennsylvania Association of Community Organizations for Change Now (“ACORN”) hereby Petitions to Withdraw from the above-captioned proceeding pursuant to the provisions of the Rules of Practice and Procedure of the Pennsylvania Public Utility Commission (“PUC” or “Commission”), 52 Pa. Code Section 5.94 and the Public Utility Code.
2. On July 24, 2009, ACORN Petitioned to Intervene in the above-captioned proceeding. This Petition was approved in a Pre Hearing Order dated July 30, 2009, and subsequently ACORN has been an active participant and stakeholder in this proceeding, representing the interests of low-income households.

3. On April 1, 2010, ACORN dissolved its status as a corporate entity and ceased to exist as an organization. Therefore, ACORN is unable to continue participating in this proceeding.
4. On October 15, 2010, Pennsylvania Communities Organizing for Change ("PCOC") a non-profit organization with a deep understanding of low-income communities and their unique utility related issues, petitioned to intervene in this proceeding and represent the specific interests of low-income households.
5. Should PCOC's Petition be granted, low-income households will have suitable representation and the instant Petition to Withdraw will be in the public interest.
6. No other party to this proceeding will suffer harm as a result of ACORN's withdrawal.

WHEREFORE, ACORN respectfully requests that the Pennsylvania Public Utility Commission grant this Petition to Withdraw and make such other order as is just and appropriate.
