RELINQUISHMENT OF A PORTION OF RIGHT OF WAY

THIS INDENTURE, made this *25<sup>th</sup>* day of *August*, 2010, between PPL ELECTRIC UTILITIES CORPORATION, formerly PP&L, Inc., formerly Pennsylvania Power & Light Company, a corporation organized and existing under the laws of the Commonwealth of Pennsylvania, having its principal office in Allentown, Pennsylvania, party of the first part, and MILTON REGIONAL SEWER AUTHORITY, Attn: George Myers, Superintendent, 5585 State Route 405, P.O. Box 433, Milton, PA 17847, party of the second part.

WHEREAS, by deed dated 4/15/1977 as recorded in DB 552 PG 579 in Northumberland County, Pennsylvania Power & Light Company (now party of the first part) sold the property to The Borough of Milton and reserved an L-shaped parcel for right of way.

WHEREAS, the party of the second part has requested a relinquishment of a portion of the aforementioned right of way as far as the parcel owned by the party of the second part is concerned. Party of the second part currently owns this property.

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) in hand paid by the party of the second part to the party of the first part, the receipt of which is hereby acknowledged, and both parties intending to be legally bound hereby, the party of the first part irrevocably relinquishes unto the party of the second part, their successors and assigns, all of its right, title and interest in and to a portion of the aforesaid right of way stated in Deed Book 552 Page 579, shown cross hatched on Exhibit "A" and titled on the legend as "Right-of-way to be relinquished", attached hereto and made a part hereof.

IT IS THE TRUE INTENT of this instrument that only the land described above and as described on the attached Exhibit "A" is hereby relinquished and this instrument in no way affects or changes the rights and privileges hereinbefore granted in the remaining part of any lands covered by the above described right of way.

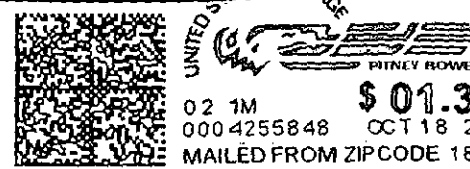
