Pursuant to 52 Pa. Code § 1.15(b), Philadelphia Gas Works, the Respondent (PGW) hereby requests a continuance of the hearing in this matter scheduled for Tuesday, January 3, 2011. In support of its motion, PGW states as follows:

1. On January 19, 2010, the Commission served the Respondent with the Complaint filed in the above captioned matter, which is a billing dispute concerning.
2. On February 8, 2010, PGW filed an Answer to the Complaint in the above captioned matter.
3. By Notice dated September 16, 2010, the Commission scheduled an In Person Hearing in this matter for October 20, 2010 at 10:00 a.m., before Administrative Law Judge Angela T. Jones, in the Commission's Philadelphia office.
4. By letter dated October 5, 2010, the Complainant requested a continuance of the October 20, 2010 hearing as that date conflicted with another court date involving the Complainant and the City of Philadelphia Water Department in municipal court in Philadelphia.
5. By notice dated October 12, 2010, the Commission scheduled an In Person Hearing in this matter for January 3, 2011 at 10:00 a.m., before Administrative Law Judge Angela T. Jones, in the Commission's Philadelphia office.
6. On January 3, 2011, counsel for PGW will be in route back to Philadelphia, returning from a planned vacation out of the country during the holiday season. Due to the heavy holiday traveling schedule, counsel for PGW could not obtain a return flight to Philadelphia on Saturday, January 2 or Sunday, January 3, 2011.
7. At this time, PGW believes that there is a possibility that the parties will


resolve the amicable matter by settlement as the parties will have additional time to discuss the issues prior to the hearing.


