III. Settlement

To date, the OCA has not participated in any settlement discussions. The OCA is willing to participate in settlement discussions in this proceeding.

IV. Witnesses

The OCA has not identified a witness at this time. The OCA intends to review the Company's Direct Testimony once submitted to determine the need for the identification of a witness. In addition, there may be issues addressed through other parties' direct testimony that would result in the OCA identifying a witness. 
