

CERTIFICATION OF SATISFACTION OF COMPLAINT

1. Complainant is Dr. Elaine F. Wasilewski and Lancaster Chiropractic & Massage Therapy Associates (hereinafter "Complainant").
2. Respondent is PPL Electric Utilities Corporation (hereafter "PPL").
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code §5.24(b).
4. PPL hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission, have mutually and voluntarily agreed on the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complaint has acknowledged satisfaction to PPL:
 - (a) Complainant has past due balance of \$1,173.02;
 - (b) Complainant disputed PPL's ability to charge her under the GS-3 Rate;

(c) Complainant acknowledges that PPL is permitted to charge her under the GS-3 Rate;

(d) Complainant will continue to be charged under the GS-3 Rate;

(e) PPL will issue a \$600.00 credit to Complainant's electric account;

(f) Complainant agrees to pay the remaining \$573.02, as follows:

(i) For each of its next four electric bills, Complainant will pay to PPL its current electric charges, plus an additional \$143.25;

(g) Thereafter, Complainant will pay her current electric charges on a monthly basis; and

(h) Complainant agrees to withdraw its Complaint with prejudice.






