
Dear Gentlemen:



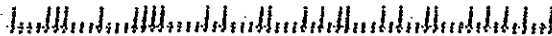
