On behalf of Comcast Phone of Pennsylvania, LLC ("Comcast") and CIMCO Communications, Inc. ("CIMCO"), I am writing to notify you that on March 13, 2010, the Federal Communications Commission approved Comcast's acquisition of the assets of CIMCO and the transaction closed on March 16, 2010. *See Applications Filed for the Acquisition of Certain Assets of CIMCO Communications, Inc. by Comcast Phone LLC, Comcast Phone of Michigan, LLC and Comcast Business Communications, LLC*, WC Docket No. 09-183, Memorandum Opinion and Order and Order on Reconsideration, FCC 10-41 (rel. Mar. 15, 2010).

This letter confirms that all CIMCO customers in Pennsylvania have been transferred to Comcast in accordance with applicable federal and state migration guidelines. CIMCO will request cancellation of its certificate of public convenience under separate cover. Additionally, Comcast will adopt and revise accordingly CIMCO's tariffs currently on file with the Pennsylvania Public Utility Commission.


