STATUS REPORT OF THE DEPARTMENT OF TRANSPORTATION

The Pennsylvania Department of Transportation ("Department") hereby files the following Status Report, pursuant to the requirements of Ordering Paragraph 21 in the Commission's Opinion and Order entered October 31, 2007, in the above-referenced matter. This status report pertains to the work ordered to be performed by the Department pursuant to the Commission's Opinion and Order entered on October 9, 1997, as subsequently modified.

1. The Fairview Road (S.R. 3016) crossing project, Crossing 17 as addressed in Ordering Paragraph Numbers 99 and 100 of the Opinion and Order entered on October 9, 1997 as subsequently modified, is currently under construction. Due to Amtrak's relocation of overhead electrical lines, there are coordination efforts underway with Amtrak.

2. The Marticville Road (S. R. 0324) project, Crossing 27, as addressed in Ordering Paragraph Number 142 of the Opinion and Order entered on October 9, 1997 as subsequently

modified is still in the final design phase. Coordination with Amtrak on their power line relocation continues. Post-construction storm water management plans were reviewed with the Department of Environmental Protection (DEP) in February and final pavement design was submitted in mid-March to the Department.




