a. Whether the proposed Merger, if approved, would impede competition in the electric retail market, thereby negatively impacting the price ratepayers, specifically PSU, must pay for energy. West Penn and FirstEnergy currently have neighboring service territories.

b. Whether the proposed Merger provides affirmative public benefits that are substantial.

PSU's position will be finalized in its evidence and briefs submitted under the schedule developed in this case.

PSU reserves the right to submit pre-filed direct testimony and associated exhibits addressing each issue identified in the preceding section.
