PREHEARING MEMORANDUM OF THE PHILADELPHIA AREA INDUSTRIAL ENERGY USERS GROUP

As requested by Administrative Law Judges ("ALJs") Dennis J. Buckley and Elizabeth H. Barnes in the November 4, 2010, Prehearing Conference Order, the Philadelphia Area Industrial Energy Users Group ("PAIEUG") hereby submits this Prehearing Memorandum.

I. HISTORY OF THE PROCEEDING

On July 1, 2009, PECO Energy Company ("PECO" or "Company") filed its Act 129 Energy Efficiency and Conservation Plan ("EE&C Plan") with the Pennsylvania Public Utility Commission ("PUC" or "Commission"). On July 20, 2009, PAIEUG filed a Petition to Intervene in this proceeding. A description of PAIEUG is set forth in Paragraph 3 of PAIEUG's Petition to Intervene. PAIEUG's Petition to Intervene was granted by ALJ Marlane Chestnut at the July 27, 2009, Prehearing Conference. On February 17, 2010, the Company's EE&C Plan, as refiled, was approved by the Commission.²

Consistent with the Commission's directives in Secretarial Letters dated June 24, 2010, and September 1, 2010, PECO filed proposed changes to its EE&C Plan on September 15, 2010. On

The Commission also addressed PECO's EE&C Plan in Orders entered October 28, 2009, November 19, 2009, and December 23, 2009.

October 15, 2010, PAIEUG filed a letter indicating that it was not filing Comments regarding PECO's proposed changes to its EE&C Plan. Similarly, on November 4, 2010, PAIEUG filed a letter

indicating that it was not filing Reply Comments in response to other parties' Answers or Comments.

III. ANTICIPATED ISSUES AND SUB-ISSUES

Based on an initial review, PAIEUG has not identified any definitive areas of inquiry. Notwithstanding, PAIEUG is concerned with whether PECO's EE&C Plan is in the public interest and whether the EE&C Plan and accompanying programs comport with Act 129 and all other applicable statutes and regulations. In this proceeding, and to the extent required, PAIEUG anticipates pursuing issues related to the Company's proposed program costs, the allocation of those costs, and PECO's proposed cost recovery mechanism. PAIEUG also expects to pursue issues as they specifically pertain to the Company's programs designed for Large Commercial and Industrial

("C&I") customers. PAIEUG reserves the right to raise further issues and to respond to issues raised by other parties.

IV. PROPOSED WITNESSES

PAIEUG is still evaluating whether it will present any witnesses in this proceeding. If PAIEUG determines that it will present such witnesses, PAIEUG will inform the ALJs and the other parties as soon as possible. PAIEUG intends to participate in this proceeding through the submission of discovery, cross-examination of other parties' witnesses, and the submission of briefs, exceptions and reply exceptions, if necessary.

V. PROPOSED SCHEDULE AND DISCOVERY RULES

PAIEUG will adhere to the schedule contained in the ALJs' Prehearing Conference Order and will cooperate with the ALJs and the parties at the Prehearing Conference to develop appropriate discovery rules in accordance with the Commission's regulations and any directives issued by the ALJs.

VI. POSSIBILITY OF SETTLEMENT

PAIEUG is willing to participate in discussions with the other parties to amicably resolve the issues in this proceeding.
