MOTION FOR CONSOLIDATION


AND NOW, comes Complainant 1-A Realty by and through its attorneys, Malkames Law Offices, files this Motion for Consolidation of Docket No. F-2010-2166554 and Docket No. F-2010-2166976, and in support thereof alleges as follows:

1. The within complaints involve the Red Maple Acres Mobile Home Park operated by Complainant.
2. Both cases involve street lights which have been attached to the electric meter of Park residents, to wit, Karen Thompson and Phyllis Ruth and Herb Ruth.
3. The utility contends that said street lights constitute foreign loads requiring the electric accounts of those residents be placed in the home of the Complainant.
4. The within Complaints involve similar issues of fact and law, to wit, the Complainant contends said foreign loads were made with the agreement of the residents, with reimbursement to the residents, and are de minimis in any event.

5. Counsel for both parties agree that said appeals should be consolidated for the convenience of the parties and the Court.



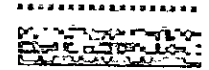
