

TO WITHDRAW


Dominion Retail, Inc., (“Dominion Retail”) by and through its counsel, hereby Petitions the Presiding Administrative Law Judges, pursuant to 52 Pa. Code §§ 5.94 & 5.101 to withdraw from participation in the above-captioned matter and to withdraw any and all pleadings submitted, including any and all documents provided and served but not yet entered into the record. In support of its Petition, Dominion Retail states and avers as follows:

1. On April 16, 2010, Dominion Retail filed a Petition to Intervene in the above-captioned matter.
2. By Second Interim Order entered on April 20, 2010, Dominion Retail’s Petition to Intervene was granted by the Presiding Administrative Law Judges, the Honorable Judge H. Corbett, Jr., and the Honorable Mary D. Long.
3. Pursuant to the procedural schedule set forth in their Prehearing Order in this matter issued April 8, 2010, Dominion Retail served the direct testimony of Thomas J. Butler on May 12, 2010.
4. Dominion Retail now wishes to withdraw from participation in the above-captioned proceeding and accordingly requests to the extent necessary in order to effectuate its

withdrawal, that the Presiding Administrative Law Judges take all necessary action under the circumstances including the withdrawal of pleadings. Dominion Retail requests that this withdrawal be without prejudice to any position it may take in any future proceeding.

WHEREFORE, Dominion Retail respectfully requests that the Commission permit it to withdraw from participation in the above-captioned proceeding and take what other action may be necessary to effectuate that withdrawal including the withdrawal of all pleadings.


