Dear Commission Members:

We have received the letters of 'Notice of Proposed Rate Changes' sent to us recently by Total Environmental Solutions, Inc., Treasure Lake Water & Sewer Divisions, DuBois, PA 15801.

We want you to consider this letter a 'formal complaint' objecting to this proposed increase in our rates!

We feel it is 'excessive and detrimental' to the majority of Residents using these services. As an example of our situation: we are on Social Security with a fixed income. We did not get a COLA this year and will not receive a COLA next year. Our medicare premiums for next year are scheduled to 'jump again' along with our supplemental insurance premiums. Add to that the anticipated energy price boosts for next year which would affect many of the products and services we need, including food and transportation and it leaves us in a precarious budget dilemma!

How can we be expected to maintain a 'frugal lifestyle' when these 'cost forces' are beyond our control? We did not ask for these 'mismanaged policies' of some of our government and service providers, yet we are now being asked to assume 'their excessive costs' with little chance to rebuff their rate schedules! **IF THESE SERVICE PROVIDERS AND SOME GOVERNMENT POLICY DRAFTERS ARE ALLOWED TO 'RAM THRU' THEIR BUDGETARY RATE HIKES, with no apparent avenue for the consumers to object, WE FEEL LIKE WE ARE LOSING OUR RIGHTS AS CITIZENS OF A FREE COUNTRY!**

We can respect any request for a 'reasonable boost' in their rates when necessary, but their planned excessive rate projections should not be permitted and would present an unmanageable burden for many of our Residents of Treasure Lake!

Please review their rate plans with a constraining attitude toward those of us who will be affected by your decisions.

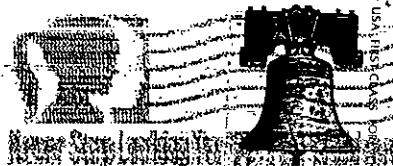
