

acknowledged satisfaction to PNG:

- (a) Complainant's gas account balance stands at \$1,352.31 after an \$800.00 Operation Share assistance grant and a \$500.00 church assistance grant has been applied.

Complainant agrees to pay the balance on his gas account as follows:

The first monthly payment upon restoration will include a \$37.00 turn on fee and 50% of the security deposit of \$206.00 plus the monthly payment agreement amount of \$262.00 per month, for a total of \$505.00;

The second monthly payment will include a \$103.00 amount on the remaining portion of the security deposit plus \$262.00 for a total of \$365.00;


The third monthly payment will include the final \$103.00 remaining on the security deposit plus \$262.00 for a total of \$365.00.

The remaining monthly payments will be \$262.00 per month until the gas account balance is paid in full and all payments are due on or before the billing due date.

- (b) PNG agrees to restore service and will continue to provide service provided the aforementioned payments are made on or before the gas bill due date.
- (c) In light of the above, Complainant has agreed to withdraw his Complaint.

WHEREFORE, PNG respectfully requests that the docket be marked closed in this matter.

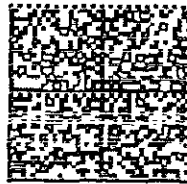
