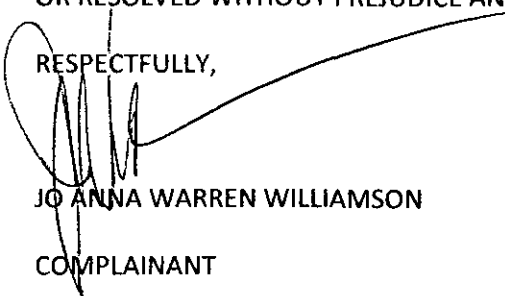
THE HEARING (TUESDAY, SEPTEMBER 7,2010); THE FINDINGS OF FACT; THE DISCUSSION; THE BURDEN OF PROOF; THE CIRCUMSTANCES OF THIS CASE; AND THE CONCLUSIONS OF LAW WERE HELD AND / OR DRAWN WITH INCOMPLETE HISTORY AND REPRESENTATION. THEREFORE THE INITIAL DECISION IS BIASED AND PREJUDICIAL. THE COMPLAINANT PROVIDED THE LAW JUDGE WITH: PERSONAL PHOTOGRAPHS/PICTURES (SHOWING THE CRACK IN MY FOUNDATION AND DAMAGE TO MY LOT); A COPY OF MY DEED; A BEAVER COUNTY PLOT PLAN DEPICTING THE LAYOUT OF THE TAXABLE PROPERTIES, THE DESIGNATED STREETS. AND ALLEYS ON PLAN NUMBER SIX; AN APPRAISAL OF MY PROPERTY; A COPY OF THE INSURANCE LETTER DENYING AND REFUSING TO RENEW MY HOME OWNERS POLICY AND THE REASONS WHY; THE ENGINEER'S REPORT AND PHOTOGRAPHS; MEDICAL DIAGNOSIS; PRESCRIBED MEDICINES; NAMES OF PHYSICIANS, PSYCHIATRIST, PSYCHOLOGIST; A COPY OF THE DEEDS TO PROPERTIES AJOINING AND BUTTED UP AGAINST MY LOT; A WITNESS LIST; AND A REQUEST FOR SUPEONAS; AND ...

THE LAW JUDGE DENIED AND REFUSED TO ISSUE SUPEONAS, SAYING THAT THE EXPERTS THAT I LISTED HAD NO BUSINESS IN OR AT A PUC HEARING. AT THE HEARING THE LAW JUDGE SAID THAT I COULD NOT TALK ABOUT THE AFFOREMENTIONED ITEMS OR DOCUMENTS SINCE THERE WERE NOT ANY EXPERT WITNESSES PRESENT. WHEN I REMINDED THE LAW JUDGE OF WHAT I UNDERSTOOD HIS CORRESPONDENCE TO MEAN AND FOLLOWED UP WITH A LETTER REGARDING MY UNDERSTANDING OF THE PRINTED MATTER THERE WAS NO RESPONSE FROM THE LAW JUDGE MAKING THE DENIAL OF EXPERT WITNESSES CLEAR. ALTHOUGH I APPEARED BEFORE THE PUC AT THE HEARING THE WAY IT WAS CONDUCTED ONLY ENABLED DUQUENSE LIGHT COMPANY THE PRIVILEGE OF LEGAL PRESENTATION. IT IS ABSOLUTELY NECESSARY FOR ALL PARTIES TO HAVE AN ATTORNEY FOR LEGAL REPRESENTATION. IT IS QUITE MISLEADING FOR THE PUC TO SAY THAT LEGAL REPRESENTATION BY AN ATTORNEY IS NOT NECESSARY.

MY HOME IS ONE HUNDRED YEARS OLD. JUST IMAGINE WHAT DISREPAIR IT WOULD BE IN IF IT HAD NOT BEEN MAINTAINED SINCE THE 1930'S. IN ADDITION ALTHOUGH THE PROPERTY LINES/LOTS' BOUNDARIES HAVE REMAINED THE SAME THE NUMBER OF BUILDINGS ON SAID LOTS HAVE CHANGED. THERE ARE GARAGES, FENCES, AND UNKEPT WILD GROWTHS INCLUDED IN THE MIX WITH THE HOUSES. THERE HAS NEVER BEEN A STREET PARALELLED TO THE SIDE OF MY LOT. THE STRETCH OF AREA IN QUESTION IS EITHER A PART OF MY PARCEL OR PART OF THE PARCELS BELONGING TO THE THREE LOTS BUTTED AGAINST MY LOT. MY HOME AND LOT HAS SHIFTED AND BOTH THE STREET SIDEWALKS AND THE WALKWAYS THAT WRAP AROUND THE FRONT AND SIDE OF MY HOUSE HAVE RAISED, CRACKED, CHIPPED, OR BROKEN INTO PIECES BECAUSE OF THE (WATER RUN-OFF- VEHICLES) SHIFTING. THERE HAS NEVER BEEN A CONTRACT WITH DUQUESNE LIGHT REGARDING THE PLACEMENT OF THEIR POLE ONTO MY PROPERTY. MY FOUNDATION CANNOT BE PERMANENTLY FIXED AND MY HOME IS GOING TO COLAPSE. IT WILL NOT TAKE THE ABUSE THAT HAS OCCURRED OVER THE MANY DECADES THAT DUQUESNE LIGHT HAS SUBJECTED IT TO MUCH LONGER AND I NEED FULL INSURANCE COVERAGE ON MY PROPERTY.

DUQUESNE LIGHT DID NOT PAY ME OR ANYONE ELSE THAT HAS OWNED THIS PROPERTY FOR PERMISSION TO PLACE THEIR POLE ON THIS PROPERTY OR IN MY YARD. UNLESS THE PUC LAW JUDGE TAKES A LOOK AT THE DOCUMENTS THAT HAVE BEEN AFFORDED YOU OR MAKES A PERSONAL TRIP TO SEE AND EXAMINE MY HOME/FOUNDATION, LOT, AND THE CONDITION OF THE POLE AND THE RISK OF CONTINUED DAMAGE TO MY FOUNDATION THIS MATTER OF C – 2009-2138578 CAN NOT BE DECIDED OR RESOLVED WITHOUT PREJUDICE AND BIAS.
