Members of the Commission:

I concur with Mr. Paul Jenkins exceptions disagreeing with the initial decision approving DLC's application for siting and construction of a 345kV transmission line.

After reviewing the information regarding this project, it is clearly evident that the resources of DLC are no match for the citizenry to refute its initiation. Even though the Commission states the burden of proof is with DLC to prove its case, the entire process is devoid of unbiased, independent experts and their testimony that would present adverse effects on wildlife, natural habitats, the environment as well as the health and safety of persons especially in close proximity to the proposed transmission line. The citizens, DLC and the Commission would benefit with the comprehensive presentations of facts, not just the compensated experts of DLC, before rendering a decision of such magnitude.

It would behoove DLC, members of the Commission and the Judiciary to take this into consideration so there can be no question before any initial decision becomes final.
