Dear Secretary Chiavetta:

On November 30, 2010, the Retail Energy Supply Association ("RESA") filed with the Pennsylvania Public Utility Commission ("PUC" or "Commission") a Notice of Withdrawal of the Protest that RESA previously filed on October 14, 2010, in the above-referenced docket, citing the Settlement in Principle that RESA and Interstate Gas Supply, Inc. d/b/a IGS Energy's ("IGS Energy") recently achieved with respect to IGS Energy's intent to use, and to operate in Pennsylvania under, the fictional name "Columbia Retail Energy."

IGS Energy hereby submits this letter in support of RESA's Notice of Withdrawal of its Protest. As previously indicated in letters filed with the PUC on November 15, 2010, and November 30, 2010, and as contemplated in the Settlement in Principle, IGS Energy agrees with RESA that a formal rulemaking proceeding on non-affiliated Natural Gas Supplier ("NGS") use of such fictional operating names is the best venue for the Commission to resolve concerns such as those embodied in the withdrawn Protest. In this regard, IGS Energy anticipates that a Petition for such a rulemaking proceeding will be filed, jointly or severally, by IGS Energy and RESA in the very near future.
