

PUBLIC STATEMENT OF THE
OFFICE OF CONSUMER ADVOCATE
PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. § 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (PUC or Commission). In accordance with Act 161, and for the following reasons, the Consumer Advocate determined to file a Notice of Intervention and to participate in proceedings before the Commission involving the Petition of PECO Energy Company (PECO).

On November 17, 2010, PECO filed a Petition for expedited approval to apply banked Alternative Energy Credits (AECs) in the Alternative Energy Portfolio Standard Act (AEPS) Reporting Years 2011-2012 and 2012-2013. In its Petition, PECO seeks approval to apply non-solar, Tier I AECs obtained and banked during its cost recovery period towards the Company's AEPS requirement in the first two full AEPS reporting periods following the end of its cost recovery period on January 1, 2011, instead of in the seventeen month period specified in the Commission's AEPS regulations.

The Consumer Advocate has determined to participate in this proceeding to protect the interests of ratepayers. Since the costs of the alternative energy resources will be recovered from ratepayers, the Consumer Advocate will seek to ensure that the processes for procurement are reasonable, that any rate recovery mechanism is reasonable, and that any resulting rates are just and reasonable.


