CERTIFICATION OF SATISFACTION OF COMPLAINT

1. Complainant is Alan William King (hereinafter referred to as "Complainant").

2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL").

3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).

4. PPL hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission, have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL:

(a) PPL and Complainant agree that Complainant's overdue balance with PPL is \$950.77, and not \$1,523.27 as set forth on his last electric bill;

(b) Complainant agrees to pay his overdue balance in 60 monthly installments of \$16/month beginning with his next electric bill;

(c) Complainant wishes to be taken off budget billing effective retroactively to his August 20, 2010, electric bill. PPL will do so;

(d) Complainant agrees to timely pay his electric bill on a monthly basis;

(e) In total, Complainant will pay his electric bill (including his currently accrued charges plus \$16 per month every month going forward; and


(f) Complainant agrees to withdraw its Complaint with prejudice.

5. PPL hereby notifies Complainants of the filing of this Certificate of Satisfaction, and that if Complainants objects or disagree with the terms of the Certificate of Satisfaction, Complainants must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.

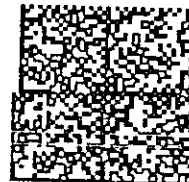
