1. The customer's account balance at 7944 Provident St Philadelphia PA is \$5,642.30.
2. This balance includes CAP arrears in the amount of \$3,531.82 for service provide to 649 N 53rd St., Philadelphia PA.
3. Accordingly, Complainant is not eligible for a Commission issued payment agreement.
4. In accordance with 66 Pa.C.S.§1405(c), “[c]ustomer assistance program rates shall be timely paid and shall not be the subject of payment agreements negotiated or approved by the Commission.” Accordingly, Complainant is not eligible for a Commission issued payment agreement.

WHEREFORE, for all of the reasons stated herein, PECO respectfully requests that the Complaint be dismissed with prejudice.
