On December 28, 2010 the Office of Consumer Advocate (OCA) filed an Intervention in response to PPL's December 2, 2010 filing in the above-captioned proceeding. The Company's December 2nd Petition seeks Commission approval to move forward with the procurement of a 50 MW block of long-term supply. The OCA intervened in order to preserve its rights in any proceeding resulting from the Company's filing.

The OCA does not have any objections to the Company proceeding with its planned 50 MW procurement as filed. The Company's filing reflects several key considerations offered by the OCA in the Collaborative process that was contained in the approved settlement of PPL's 2011-2013 Default Service Proceeding at Docket No. P-2008-2060309. 
