
Dear Ms. Chiavetta:

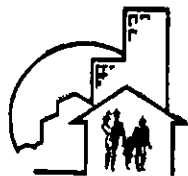

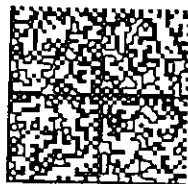
