Pursuant to the provisions of its Alternative Regulation and Network Modernization Plan, approved by the Pennsylvania Public Utility Commission at Docket No. P-00961024, Frontier Communications Commonwealth Telephone Company ("Frontier Commonwealth") respectfully informs the Commission that on February 1, 2011, it will submit its annual Price Stability Index/Service Price Index filing. At this time, it is not anticipated that Frontier Commonwealth will request any rate changes on February 1, 2011. However, if Frontier Commonwealth identifies any proposed rate change components following its February 1st filing, it will follow its advance notice requirements prior to any filings being submitted to the Commission.



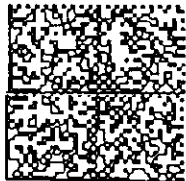
