Dear Ms. Chiavetta:

On December 21, 2010, PPL Electric Utilities Corporation ("PPL Electric") submitted an original and eight (8) copies of Supplement No. 102 to PPL Electric's Tariff - Electric Pa. P.U.C. No. 201. That tariff supplement was filed in compliance with the Commission's Orders entered on December 2, 16, and 21, 2010, and its Secretarial Letters issued on December 16, and 20, 2010, in the above-captioned proceedings. Supplement No. 102 sets forth revised distribution service rates, revised Transmission Service Charges, Universal Service Rider rate, Generation Supply Charges, including optional time-of-use ("TOU") rates, and Smart Meter Charges to be effective for service on and after January 1, 2011.

Although Supplement No. 102 became effective on January 1, 2011 pursuant to the Commission's Secretarial Letter dated December 30, 2010, it was determined that PPL Electric inadvertently omitted Docket No. R-2010-2201138 from the Title Page (page 1) of Supplement No. 102. As a result, PPL Electric is submitting a replacement Title Page for Supplement No. 102 to correct this omission and for completeness of Tariff - Electric Pa. P.U.C. No. 201.


