Dear Ms. Williams:

This letter confirms the settlement and payment plan negotiated between Assured Packaging, Inc. ("Complainant") and PECO Energy ("Company") on this date as to arrears owed to the Company in the amount of \$32,636. The terms of the settlement are as follows:

- remittance by Assured Packaging to PECO Energy of an initial payment of \$10,650.05 by January 28, 2011;
- remittance of monthly payments for the balance of the arrears beginning February 28, 2011 and continuing through July 28, 2011 in the approximate amount of \$3,664.41; and
- current monthly payments for ongoing usage must also be paid when due (beginning in February).

By acceptance of this settlement, Complainant confirms that he is satisfied with the settlement terms and no longer wishes to pursue this matter, consistent with the foregoing settlement terms.
