indicated service was to be provided to all of the customer classes – which also includes
Governmental Customers. Please confirm the proposed customer groups.

Energy Services Providers, Inc. d/b/a Pennsylvania Gas & Electric plans to offer retail service to all customer classes, residential, commercial, industrial and governmental. We have revised Section 4(c) and have enclosed it for reference.

2. In Section 4(d) PROPOSED SERVICE AREA – a list of the EDCs for which the applicant proposes to provide service was included; the list included Met-Ed, Penelec and Penn Power. However the Certificate of Service which was provided did not include these companies. Please address the discrepancy.

Energy Services Providers, Inc. d/b/a Pennsylvania Gas & Electric does not plan on providing services in the Met-Ed, Penelec and Penn Power territories. We have revised Section 4(d) and have enclosed it for reference.
