NOTICE OF CONSUMMATION

On behalf of PaeTec Communications, Inc., US LEC of Pennsylvania LLC d/b/a PAETEC Business Services and McLeodUSA Telecommunications Services, LLC d/b/a PAETEC Business Services (collectively, the "PAETEC Entities"), Talk America, Inc., LDMI Telecommunications, Inc., Cavalier Telephone Mid-Atlantic, LLC and Intellifiber Networks, LLC (collectively, the "Cavalier Entities") and PAETEC Holding Corp. ("PAETEC") (the PAETEC Entities, the Cavalier Entities and PAETEC collectively, the "Applicants") and pursuant to the Orders issued in these dockets, this letter notifies the Commission that on December 6, 2010, the Applicants completed (1) the indirect transfer of control of the Cavalier Entities to PAETEC Holding Corp., (2) the participation of the PAETEC Entities and the Cavalier Entities in the new financing arrangement of PAETEC of up \$450 million (the Commission authorized new financing

arrangements of up to \$600 million and (3) the participation of the Cavalier Entities in the existing financing arrangements of PAETEC of \$1 billion, of which \$950 million is

currently outstanding. Additional details regarding these transactions were provided in the Applications and Supplements thereto.

At this time, Applicants do not have any affiliated interest agreements to file. In addition, the Cavalier Entities do not need to make any tariff revisions as a result of the transactions.


As required by the Orders, a summary of the new financing arrangement in the amount of up to \$450 million follows:

Security:	Unsecured. The PAETEC Entities and Cavalier Entities are Subsidiary Guarantors under the Notes in order to guarantee the payment and performance of the Notes.


