Dear Secretary Chiavetta:

By two letters, each dated June 21, 2010, Verizon Pennsylvania Inc. (Verizon) notified Comcast Phone of Pennsylvania, LLC and Comcast Business Communications, LLC respectively, that each of the two Comcast entities was in default of bill payment obligations to Verizon under applicable interconnection agreements and tariffs. The letters stated that absent timely payment, Verizon would suspend processing of Comcast service orders and/or would terminate all services provided under an applicable interconnection agreement, on or after September 8, 2010.

By letters dated September 16, 2010, October 25, 2010 and December 2, 2010 Verizon informed the Commission that by mutual agreement the parties had extended the date for any such termination notices first to October 25, 2010, then to December 10, 2010, and then to January 21, 2011. By this letter Verizon informs the Commission that by mutual agreement the parties have extended the date for any such termination notices to February 25, 2011.

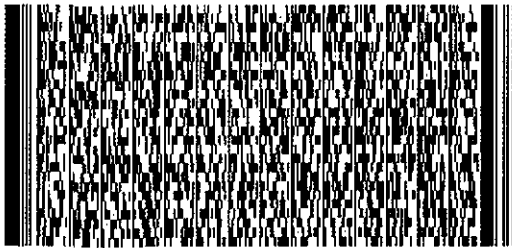

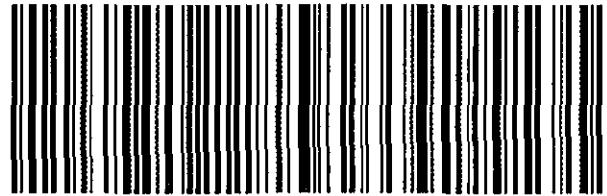
