Sample Disclosure Statement Format for Natural Gas Suppliers

This is an agreement for natural gas services, between Planet Energy (Pennsylvania) Corp. and <u>customer's name and full address.</u>

Background

- We at Planet Energy (Pennsylvania) Corp. are licensed by the Pennsylvania Public Utility Commission to offer and supply natural gas services in Pennsylvania. Our PUC license number is <u>A-2010-2216375</u>.
- We set the commodity prices and charges that you pay for natural gas supply. The Public Utility Commission regulates distribution or delivery prices and services. The Federal Energy Regulatory Commission regulates interstate pipeline prices and services.
- You will receive a single bill from your Natural Gas Distribution Company for both its charges and for our charges.
- Right of Recision You may cancel this agreement at any time before midnight of the third business day after receiving this disclosure.

Definitions

- Commodity Charges The charges for basic natural gas supply service which is sold either by volume (ccf or Mcf) or heating value (dekatherms).
- Interstate Pipeline Charges Charges for moving natural gas to the distribution lines of a distribution company.

Terms of Service

1. (a) Basic Service Prices

You will pay <u>rate per</u> (Mcf/Dth/ccf) for the commodity of natural gas. Commodity charges include estimated total state taxes. Commodity Charges exclude Pennsylvania sales tax, if applicable.

2. Length of Agreement

You will buy your natural gas services for the above street address from Planet Energy (Pennsylvania) Corp. on a date set by your natural gas distribution company and will continue for XXXXX.

3. Penalties, Fees and Exceptions - Early Cancellation Fee - For residential customers: the greater of (i) XXXXX dollars if the remaining term is less than twelve months and XXXXX dollars if the remaining term is twelve months or greater.

For non-residential customers: the difference between the fixed price or the fixed price component of a hybrid rate in effect for the remainder of the current term and the price at which Planet can sell such commodity following the termination multiplied by the projected amount of commodity to be consumed by you for the remainder of the current Term at such fixed price or fixed price component, as applicable.

4. Cancellation Provisions – You may rescind the agreement by calling Planet Energy (Pennsylvania) Corp.'s toli free number within 3 business days of receipt of the sales agreement. In respect of month-to-month agreements, you may cancel the agreement on 30 days notice prior to the end of the month of termination. Planet Energy (Pennsylvania) Corp. may terminate this agreement if you fail to pay for gas supply or any other amounts payable under the agreement, you attempt to cancel or terminate the agreement at any time after the expiration of your rescission period or you breach any term of the agreement.

5. Agreement Expiration/Change in Terms /Renewal Provision - If you have a fixed term agreement with Planet Energy (Pennsylvania) Corp. and it is approaching the expiration date, renewal period or if we propose to change terms of service, we will send you two (2) advance notices either in your bill or in separate mailings between 45 and 90 days before either the expiration date or the effective date of the changes. We will explain your options in these two (2) advance notices.

6. Dispute Procedures

Contact us with any questions concerning our terms of service. You may call the PUC at 1-800-692-7380 if you are not satisfied after discussing your terms with us.
