**Disclosure Statement for  
Electricity**

This is an agreement for electric generation service, between Planet Energy (Pennsylvania) Corp. and customer's name and full address.

**Background**

- We at Planet Energy (Pennsylvania) Corp. are licensed by the Pennsylvania Public Utility Commission to offer and supply electricity generation services in Pennsylvania. Our PUC license number is A-2011-2223534.
- We set the commodity prices and charges that you pay for electricity supply. The Public Utility Commission regulates distribution prices and services. The Federal Energy Regulatory Commission regulates transmission prices and services.
- You will receive a single bill from your Electricity Distribution Company for both its charges and for our charges.
- Right of Rescission - You may cancel this agreement at any time before midnight of the third business day after receiving this disclosure.

**Definitions**

- Generation Charge - Charge for the generation of electricity.
- Transmission Charge - Charge for moving high voltage electricity from a generation facility to the distribution lines of an electric distribution company.

**Terms of Service****1. (a) Basic Service Prices –**

Fixed Rate Service: You will pay \_\_\_ per kWh plus applicable taxes for electric generation service.

Variable Rate Service: You will pay a variable rate per kWh for electric generation service. The variable rate will reflect the cost of electricity, including energy, capacity, settlement, ancillaries, related transmission and other market-related factors; plus all applicable taxes, fees, charges, costs, expenses and margins.

Hybrid Rate Service: You will pay a combination of a fixed and variable rate for electric generation service. The rate for 50% of your consumption will be \_\_\_ per kWh plus applicable taxes and the rate for the other 50% of your consumption will be a variable rate that will reflect the cost of electricity, including energy, capacity, settlement, ancillaries, related transmission and other market-related factors; plus all applicable taxes, fees, charges, costs, expenses and margins.

In respect of Fixed Rate Service or Hybrid Rate Service, you will also pay or receive a charge or credit for your share of a balancing amount based on the cost or benefit to

Planet Energy (Pennsylvania) Corp. on balancing the pooled consumption of its customers with the aggregate fixed price supply arrangements for such customers.

**2. Length of Agreement:**

You will buy your electricity generation service for the above street address from Planet Energy (Pennsylvania) Corp. on a date set by your Electric Distribution Company and will continue for XXXXXX.

**3. Penalties, Fees and Exceptions**

**Early Termination** – If Planet Energy (Pennsylvania) Corp. terminates your agreement for breach by you, you agree to pay liquidated damages equal to \$0.01 per kWh multiplied by your estimated consumption for the remainder of the term of the agreement had the agreement not been terminated.

**4. Cancellation Provisions**

You may cancel this agreement at any time before midnight of the third business day after receiving this disclosure. Planet Energy (Pennsylvania) Corp. may terminate this agreement if you fail to pay for electricity supply or any other amounts payable under the agreement, you attempt to cancel or terminate the agreement at any time after the expiration of your rescission period and you breach any term of the agreement.

**5. Agreement Expiration/Change in Terms/Renewal Provisions**

If you have a fixed term agreement with Planet Energy (Pennsylvania) Corp. and it is approaching the expiration date, renewal period or if we propose to change terms of service, we will send you two (2) advance notices either in your bill or in separate mailings between 45 and 90 days before either the expiration date or the effective date of the changes. We will explain your options in these two (2) advance notices.

**6. Dispute Procedures**

Contact us with any questions concerning our terms of service. You may call the PUC if you are not satisfied after discussing your terms with us.
