I was not present at the 3-11-2010 meeting held with James Cawley Chairman. I had previously requested a telephonic hearing due to my health problems which include the following - seizures, strokes, permanent foot neuropathy and short term memory loss - a permanent side effect from my chemotherapy.

I complied with Judge Fordham's order to pay \$253 per month, submitted the requested medical co-pays that previous counsel requested.

A few months after the hearing PECO contacted with a new payment arrangement of my monthly bill plus \$72.07 until the balance was paid.

This I received I owed nothing to PECO, I contacted PECO more than several times to verify.

I then received the decision of the Commissioners that I pay amount specified within six months - this is impossible. You will note our income situation has changed.

My husband's gross income is quite

different from his net income.

My husband has a serious back injury now and our expenses have changed.

Once again I request a telephonic hearing.

I have provided as much documentation as possible.

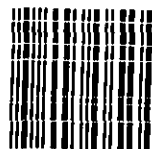
