
This supplements my letter to you, dated February 3, 2011, about the status of this matter.

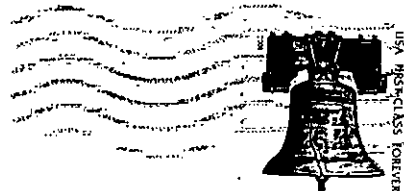
