

PPL hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant have acknowledged satisfaction to PPL:
 - (a) Complainant, Fernando A Perez, and Respondent, PPL, agrees that Complainant will pay \$250 by February 25, 2011. Thereafter, Complainant will pay the remaining \$98 by March 11, 2011. Thereafter, beginning with the bill due at the end of March, 2011, Complainant will pay her monthly budget bill plus \$31 per month towards arrearages, until all arrearages are paid in full.
