

Dear Secretary Chiavetta:

After wasting the time and resources of the Commission as well as the Complainant by making a Motion to Strike the Reply Brief of Dale Sattar, Aqua now states in their letter that " Aqua will not waste the time and resources of the Commission by filing further pleadings ".
