Dear Secretary Chiavetta:

By Order entered January 14, 2010, the Commission granted the natural gas supplier (NGS) application for Rhoads Energy to serve Residential and Commercial customers in the service territory of UGI Utilities, Inc. Due to the success of the licensee's NGS activities, Rhoads Energy is requesting amendment of its license and authority to serve Industrial and Governmental customers in the service territory of UGI Utilities, Inc.

The published notice of Rhoads Energy's original license application stated as follows:

*Application of **Jerome H. Rhoads, Inc.** d/b/a "**Rhoads Energy Corporation**" For Approval To Offer, Render, Furnish Natural Gas Supply Services To The Public In The Commonwealth Of Pennsylvania, Docket No. **A-2009-2138310**.*

On October 27, 2009, **Jerome H. Rhoads, Inc.** filed an application with the Pennsylvania Public Utility Commission ("PUC") for a license to provide natural gas supply services as a supplier of natural gas. **Jerome H. Rhoads, Inc.** proposes to sell natural gas and related services in the service territories of UGI Utilities, Inc. and PECO Gas in Pennsylvania under the provisions of the Natural Gas Choice and Competition Act.

In accordance with the Commission's approval of similar amendments to license applications and authority, additional publication is neither necessary nor required. *See, e.g.,* Exelon Energy Company, A-2008-2079002 (amendment requests of 11/3/09 and 10/29/10). A copy of this request has been served in accordance with the attached Certificate of Service.


