

OF PENNSYLVANIA AMERICAN WATER COMPANY**


AND NOW, pursuant to ordering paragraph 2 of the December 15, 2010 Prehearing Order #2 of Administrative Law Judge David A. Salapa ("ALJ Salapa"), the Respondent, Pennsylvania American Water Company ("PAWC" or "Company" or "Respondent"), by and through its undersigned attorneys, and with the consent and on behalf of the other parties hereto, hereby submits a Status Report and represents as follows:

1. In his Prehearing Order #2, ALJ Salapa directed the parties within 90 days of that order to notify him in writing whether further action on the above-captioned matter is required.

2. At this time, the parties remain in settlement negotiations and are in the process of exchanging proposals. Discovery between the parties also remains ongoing.

3. The parties continue to believe that a reasonable settlement may be reached and that further action in the above-captioned matter should be stayed for not more than an additional sixty (60) days so as to afford the parties an opportunity for further settlement discussions.

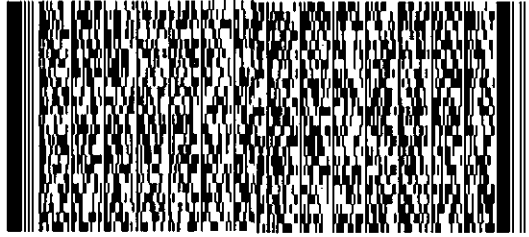
