Dear Secretary Chiavetta:

In compliance with the Pennsylvania Public Utility Commission's ("Commission") Order entered March 1, 2011 in the above-referenced proceeding, which approved the Joint Petition for Partial Settlement and ruled on the single remaining issue in the above-referenced proceeding, enclosed for filing please find the following on behalf of PPL Electric Utilities Corporation ("PPL Electric"):

1. Supplement No. 104 to Tariff Electric PA. P.U.C. No. 201, with an issue date of March 16, 2011 and an effective date of March 17, 2011;
2. Request for Proposals ("RFP") Process and Rules – Solar Renewable Energy Credits for Compliance with Pennsylvania's Alternative Energy Portfolio Standards Act;
3. 2011 Solar Renewable Energy Credit – Supply Master Agreement ("SREC SMA");
4. 2011 Solar Aggregator – Supply Master Agreement; and
5. 2011 Rules for the Small-Scale Solar Set-Aside Program.

It is noted that no substantive change was made to the tariff supplement from the form of tariff supplement that was included with PPL Electric's Petition and that was adopted pursuant to the Settlement. In addition, the RFP and the SREC SMA are consistent with the forms of documents that were filed with the Petition, modified consistent with the terms of the Settlement. Finally, the Solar Aggregator RFP and Rules are new documents, prepared consistent with the terms of the Settlement.

Within the next week, PPL Electric will begin the RFP process for the first solicitation under the SREC procurement. The first procurement under the Solar Aggregator Set-Aside will not be undertaken until after the prices have been approved under the SREC RFP, because under the approved Settlement, the average weighted price from the SREC RFP establishes the price under the Solar Aggregator Set-Aside.


